spect to the specific complaint regarding wearing uniform by Civil Defence Volunteers identical to Delhi Police personnel, the GNCTD has been asked to take necessary corrective action in this regard.

During covid pandemic the civil defence corps challaned people for not wearing masks and not following social distancing or covid appropriate norms.The Delhi police had lodged FIR's against civil defence corps for issuing fake challans. NEELGAIS, PEACOCK, MONITOR LIZARDS, BIRDS, RABBITS ALSO HAVE RIGHT TO LIVE, **DWARKITES REMINDS TO CMD NBCC & VC DDA: BHARAT VANDANA PARK-PART III**

Amid the reports of death of neelgais.peacock.monitor lizards.rabbits etc and damage to waterbody at Bharat Vandana Park social activists of Dwarka have lodged a complaint against PK Gupta CMD NBCC, other competent officials and the contractor. Speaking to Dwarka Express social activist Robin Sharma said we are not against development but we will not allow NBCC or DDA to kill helpless animals. Robin said the NBCC & DDA had earlier committed to rehabilitate the animals at some jungle or zoo but till date no action has been taken, resulting in death of poor animals. This is clear case of criminal negligence abetting to death of animals.

Robin Sharma lodged a complaint with the PMO, Lt Governor & Chief Minister Delhi. The Delhi forest department has started the proceedings as referred by the office of CM Delhi.

The environment group Green Circle Dwarka had as far as in 2015 determined the area to be rich in biodiver-



sity, recorded several species of animals there and even assisted in rejuvenating a water body there. It had been urging the local authorities to develop the expanse as an eco-sensitive zone. However, in 2019. Delhi Development Authority redeveloped it into the Bharat Vandana Park comprising several zones, including eco-forests, for adventure and amusement and with parking for over 1,600 four-wheelers. According to Capt Maan, a prominent eco activist and active member of Green Circle, in 2015 DDA had appointed professor CR Babu to inspect the Bharat Vandana Park and Mr. Babu had suggested DDA to develop the area as bio diversity park but later on in 2019 the multicrore project was launched by DDA and it destroyed the

natural habitat of animals.

Selvaraian, eco warrior demanded protection for remaining Neelgai's, the antelope is Delhi state animal. Selvaraian said the Delhi forest department must take appropriate action to protect the animals and ensure a criminal case to registered against the NBCC & DDA officials

Shobhit Chauhan eco warrior had lodged complaint to CMD NBCC in December 2021 to protect Neelgais. Shobhit said the animal lovers tried to protect life of a neelgai which met with an accident but after some days the neelgai died, Shobhit said CMD NBCC & DDA officials must be booked under relevant section of Wild Life Protection Act for gruesome deaths of animals.

Dwarka Express with the help of Green Circle and other social activists will continue its efforts until the govt ensures rehabilitation of the neelgais & other animals to a safe zone and book officials and contractors for death of poor animals.

The Shahjahanabad CGHS RWA invioted Monica Miglani. Mr. Saquib Rasool, President welcomed her and her



Historically, The Civil Defence Policy of the Government of India, till the declaration of Emergency in 1962, was confined to making the States and Union Territories conscious of the need of civil protection measures and to ask them to keep ready civil protection paper plans for major cities and towns under the then Emergency Relief Organization (ERO) Scheme. The Chinese aggression in 1962 and the Indo-Pak conflict in 1965 led to a considerable re-thinking about the policy and scope of Civil Defence. The Civil Defence Act, 1968 (Act 27 of 1968) was passed by Parliament in May 1968. The Act extends to the whole of India and provides for among other things measures not amounting to actual combat, for affording protection to any person, property, place or thing in India or any part of the territory thereof against any hostile attack, whether from air, land, sea or other places, or for depriving any such attack of the whole or part of its effects, whether such measures are taken before, during, at or after the time of such attack.








Over 12 lakh people die due to antimicrobial resistance every year; doctors blame it on antibiotics overuse

A study recently published in The Lancet provides a comprehensive assessment of the global burden of Antimicrobial resistance (AMR) which poses a major threat to human health. The researchers estimated deaths and disability-adjusted life-years (DALYs) attributable to and associated with bacterial AMR for 23 pathogens and 88 pathogen-drug combinations in 204 countries and territories in 2019. Their approach was divided into five broad components: Number of deaths where infection played a role, proportion of infectious deaths attributable to a given infectious syndrome, proportion of infectious syndrome deaths attributable to a given pathogen, the percentage of a given pathogen resistant to an antibiotic of interest, and the excess risk of death or duration of an infection associated with this resistance. Also Read -One in three elderly develop new conditions after COVID-19: US study On the basis of our predictive statistical models, there were an estimated 4.95 million deaths associated with bacterial AMR including 1.27 million deaths attributable to bacterial AMR. The six pathogens for deaths associated with resistance are: Escherichia coli, followed by Staphylococcus aureus, Klebsiella pneumoniae, Streptococcus pneumoniae, Acinetobacter baumannii, and Pseudomonas aeruginosa, the study says.

What is AMR

Dr Ramesh Chandana, chairman, safety, quality, laboratory and blood bank at the Asian Institute of Medical Sciences tells you that this condition defines a situation when the bacteria has developed resistance to the available antibiotics. "There are different kind and categories of such medicines that are there in since the time Penicillin was first coined by Alexander Fleming in 1929. Microbial means a microorganism, basically bacteria, and they develop resistance to antibiotics," Chandana told News9.

When are antibiotics needed

He tells you that the bacteria is much smatter than humans. "They have been here for millions of years. It all comes down to survival. As we developed antibiotics, the bacteria too found a way to survive and developed resistance. Yes, drug abuse or rather misuse or over use of antibiotic is the cause. Have a cold, pop a pill, tummy upset, pop a pill is a no-no. Around 60 per cent of diarrhoea are viral; the same is true for upper respiratory tract infections. Antibiotics are not needed. But people don't know this and they visit chemists and buy antibiotics for every disease. Far worse is the fact that the entire course is not taken. If the course



was for five or seven days, some people stop having antibiotics after three days because they felt better. Even doctors are prone to prescribe antibiotics because they want their patient to get well soon. Even in class I and II surgeries, only a shot of antibiotics is needed - just before the operation. It is only in class III and IV surgeries that the patient requires an entire course," Dr Chandana added.

Reasons for resistance

Dr Om Srivastava, co-director, Infectious Diseases, Sir HN Reliance Foundation Hospital in Mumbai tells you that there are several reasons for AMR in the country. "Most times, it is use of inappropriate antibiotics. A person has a common cold or a tummy upset the easiest thing he does is to have an antibiotic for the same. But was the right medicine to do the right job? What is the dosage for the same? Patients don't consider these while taking hasty decisions. These symptoms last for two-three days and when the patient becomes asymptomatic, he automatically stops the treatment without taking the entire course. This leads to resistance to the next infection. In other words, inappropriate use, inappropriate duration and inappropriate combinations are responsible for AMR that one is seeing at present," Srivastava said.

AMR prevalence

Dr Ankita Baidya, consultant, Infectious Disease, HCMCT Manipal Hospital in Dwarka, New Delhi said that about 60 per cent of the bugs detected in hospital setting shows Extended-spectrum β -lactamases resistance. "The reason for such high prevalence in the country stems due to the sale of over-the-counter medicines. Whether there is an indication of an infection or not, people end up taking antibiotics. This disturbs the system and leads to AMR. These bugs even transfer the resistance among themselves," Baidya warned.

Flip side

The biggest fallout is that you have a patient with an infection and there is no antibiotic that is going to work. "People will end up sending more time, effort and money on treating an infection that could have been treated easily with shorter duration and even oral antibiotics instead of taking them intravenously. He may end up taking more antibiotics that is needed. Instead of taking one antibiotic, he may need a combination of them," Srivastava opines.

What can be done now?

According to Dr Baidya, the solution lies not in improving the antibiotics and limiting the use but improvement in prescribing the antibiotic format. "There is an Antimicrobial stewardship pro-

gramme that promotes the appropriate use of antimicrobials (including antibiotics), improves patient outcomes, reduces microbial resistance, and decreases the spread of infections caused by multidrug-resistant organisms. The idea is to give the right antibiotic to the right person. If the programme is followed to a T, there will be marked improvement in the emergence of superbugs," Baidya said. There is also a need to regulate the antibiotics that are being used in the animal industry, Srivastava says. "We must stop the use of medicines in animals to increase their weight. A nonvegetarian can end up developing AMR due to this. We must stop prescription drug abuse. If the doctor has prescribed antibiotics for a condition, the entire course needs to be taken and not stopped mid-way," Srivastava added. He tells you that there is no specific organ that gets affected due to AMR. "It is just that every infection that requires an antibiotic will show drug resistance. The challenge then that comes up is that doctors have very few options available. Therefore, there is need to create awareness and peg responsibility to limit the irresponsibility that one is seeing now. Hopefully, with these steps, one will see good results in a short period of time," Srivastava said in conclusion.

Constant break in studies will be very harmful for the students future and health



Two years ago, the whole world came to a standstill because of an unprecedented outbreak of coronavirus, a dangerous new virus that spread quickly through communities worldwide. A major impact was felt by schools all over the world which had to be closed down to stop it's spread. At first, it felt like a long vacation which was enjoyable for students but as time passed by, students craved for normalcy to return. In these two years we have learned a lot. One of the biggest lessons was that although online learning has managed to keep education alive in these dire times, it cannot completely replace the traditional education

Now that the pandemic seems to be waning, Life is returning back to the way it was with most institutions reopening. But reopening of schools still remain a topic for debate. Some students want to return to schools while some still want to take classes in the comfort of their homes. Parents are also reluctant to send children to school because of the fear caused by this virus. They need to understand that this constant break in studies will be very harmful for the students future and health. In my opinion, schools should be reopened and the online aspect should be stopped completely, because as long as there is an option which lets people to be comfortable, they will choose it.

Both online and offline systems of education have their advantages and disadvantages. Online education has become a flexible teaching method wherein students can easily gain access to study material in the comfort of their homes. The students can easily set their own pace of learning as long as they have the right equipment and access to proper Internet connection. But as much as online education is predicted to be the future of learning, it cannot replace the holistic aspect of offline education. Offline education allows students to closely interact with the teachers and fellow students as well as participate actively in live discussions. Offline classes also provide an excellent opportunity for students to develop a strict schedule and adhere to it. It also allows teachers to monitor the responses and behaviour of the students and accordingly address them as and when required individually.

During online classes, quite a few students pay no attention to what is being taught and do what they want with their cameras off and microphones muted but the student teacher interaction is very important. On the other hand, offline classes allows students to immediately address the doubts and receive quick feedback. It also allows for activities, debates and discussions which helps students build up their confidence and social skills. 


